1. A smart 3 bedroom apartment in Kingsthorpe Northampton had been let to students; they had severely neglected the property and couldn't be let due to its condition. This was not only a concern to the landlord but was causing concern to other residents within the new apartment block.

Sleephaven were instructed to carry out the following work to restore the property to its original condition: Plastering, some property maintenance, painting & decorating, a full flat clean throughout including appliances, carpet cleaning where possible and fitting of new carpets.

As a result, just 5 days after the work was complete the property was let for £595 per month

2. A 3 bedroom semi detached property was being let in Northampton, however the garden was severely over grown and numerous trees were blocking out the sun and encroaching on the neighbour's garden.

Therefore Sleephaven were asked to carry out the following work: Removal of 17 Leylandi trees, a full garden clearance and general maintenance.

A full house clean, plus full professional carpet clean. Garden maintenance, plus repairs to and replacement fencing.
