

Is risk assessment a legal requirement?

It is a legal requirement for every employer and self-employed person to make an assessment of the health and safety risks arising out of his work. The purpose of the assessment is to identify what needs to be done to control health and safety risks. This is a particular requirement within Regulation 3 of the Management of Health and Safety at Work Regulations 1999.

You only need to record the assessment if you have 5 or more employees. However, many organisations for which you will carry out work have an expectation that you have written risk assessments in place before you are offered work. In particular principal contractors and main contractors within the construction and building industry require their sub contractors to have written risk assessment and method statements in place for all work that is carried out on their behalf. The HSE have expectations that any risk assessment is suitable and sufficient and is specific to the work being carried out. Generic risk assessments are not suitable as they do not identify site specific hazards and therefore do not contain suitable and sufficient control of the risks that will be encountered.
