# **Grants for People on Benefit**

#### Free Loft Insulation Top-up

Regardless of how much insulation is in your loft, we can top it up for you to a depth of around 300mm (12 inches). In many cases the works will be completely free and you could save up to £240 a year<sup>1</sup> on your heating bills.

#### **Free Cavity Wall Insulation**

You could save up to £275 a year<sup>1</sup> by having your cavity walls insulated and the work is usually free!\* Even homes built in the last 25 years may still benefit from additional insulation in the walls.

#### Roof in Room, Flat Roof and **Underfloor** Insulation

If your home has a room in the roof such as a dormer bungalow, or a flat roof, you could be spending far more to heat your home than you need to. We can offer grants to insulate all of the walls and ceilings including the sloping roof area, we may even be able to insulate under your floors, helping to save you money and keep you warmer!

#### **Partial Grants for Double Glazing** (for homes with single glazing)

If your home still has single glazing, we can provide a grant of up to £2,000 to upgrade your home to modern double glazed windows. The work will not be free, grants will range from 5-20% of the cost so you (or your landlord) will be required to fund the balance. Grants will be highest for larger homes that are heated by a fuel other than mains gas.

#### **Grants for Communal Heating** (including for landlords)

Grants are available towards the cost of installing heating systems where at least 2 properties will be connected to the same heating source. This may be a landlord with a block of flats, a home with an annex, where adjacent properties are owned by the same family, a park home site, or neighbours who are willing to share their heating system.
